NextGen CM/ECF: What to Know **About Your Court's Conversion**

Central Sign-On in the next generation (NextGen) CM/ECF system allows filers to access PACER and NextGen systems using a single PACER account.

In NextGen, each user is required to have an individual, upgraded PACER account. When your court announces it will implement NextGen, or if it has already converted, there are a few steps you should take to ensure you are ready.

- 1. You must have a PACER account. If you do not have one, go to: pacer.psc.uscourts.gov/pscof/ registration.jsf. Once registered, you will have an upgraded account.
- 2. You must have an upgraded

PACER account. If you already have a PACER account, ensure it is upgraded by logging in to Manage My Account at pacer.gov.

- 3. If you are an e-filer, you must link your e-filing account to your PACER account after your court converts.

User Tips & Reminders

Resetting a Password: Know Your Security Information

To recover a lost or forgotten PACER password, you must know the answers to the security questions you set up during registration. If you are unsure of the answers, update them as soon as possible and keep them in a safe place. You may update security information online at pacer.gov. Click Manage my Account. After you log in, click Set Security Information under Settings.

Receiving Faster, More Efficient Support from PSC

When you contact PSC for assistance, please include the following information in your email or web messages to ensure you get the help you need, when you need it:

- Account number and username
- Specific federal court your issue involves, if applicable
- Specific issue you are having (e.g., login reset questions)

Providing this information during your initial request could help expedite your issue resolution.

How to Retain Your PACER **Account after Moving Firms** When you leave your firm, there is no need to create a new PACER account. If your account was part of a PACER Administrative Account (PAA), you may either unlink it (under Manage My Account), or have the firm's PAA administrator unlink your account. If you move to another firm or if you work individually, your PACER account remains with you. NOTE: When you leave your firm, update your account information (e.g., email, address, etc.) at pacer.gov under Manage My Account.

How to Handle Individual Accounts Within Your PAA

In NextGen, e-filers need their own, individual PACER accounts. The PACER Administrative Account (PAA) helps firms consolidate billing, allowing you to manage and pay for all charges on one bill.

Registering for a PAA

To register for a PAA, go to pacer.gov/register and click on Firm Billing. Once you have registered for a PAA, you can add and unlink individual PACER accounts as needed.

Adding a User to Your PAA

A new individual PACER account may be created at pacer.gov/register. When setting up an account on behalf of another user, it is important to use the correct DOB to avoid any issues with identifying the account.

A new employee would provide you with his or her last name and 7-digit PACER account number. If the employee does not have a PACER account, he or she would need to create one and then provide you the account number so you can add them to your PAA.

Removing a User from Your PAA

If your firm already has a PAA and you need to remove an attorney from the account, you can unlink the account so that you are no longer responsible for PACER charges after they leave.

Usage Fees: How and When Are Users Charged for Access to PACER?

Access to case information through PACER costs \$.10 per page for all users. This charge applies to accessing each page of search results; even if your search yields no matches.

The following describes instances in which PACER charges fees:

- Fees for case documents, docket sheets, or case-specific reports are \$.10 per page. This fee is capped at 30 pages (\$3.00).
- The fee cap does not apply to searches, reports that are not case-specific, and transcripts of federal court proceedings.
- If you perform a search, the fee is \$.10 per page for the search

- Access to an audio file of a court hearing via PACER costs \$2.40 per file.
- There is no additional fee to print or save the information once it has been accessed.

If you accrue \$15 or less in a quarter, your fees will be waived. Otherwise, your PACER account will be billed for all usage.
