Public Access Changes for PACER Users

1 Additional Filer Information for Public Docket Report

Previously, courts only had the option to display the filer's initials at the end of the docket text on a public docket report. A new configurable option is available that allows a court to display more detailed filer information based on the type of filer. The below is an example for how the docket entries may look if a court configured the report to display the full name of the filer for docket entries filed by a public filer while displaying the initials for the docket entries filed by court staff.

2 PACER Advanced Search Enhancement

In 4.1, the Advanced Search option for PACER was enhanced to now include search criteria based on the originating case number. In addition, the report output now displays the district of origin and the adversary/lead originating case number.

3 4.1: New Option to View the Combined Current Page Number and Count in a PDF Header

Previously, when a user combined multiple documents using the "View Multiple Documents" feature, selected the Show PDF Header, and clicked the "Include Page Numbers" checkbox, only the total page number count displayed for the combined documents. There was no option to display the *current combined page number* and total page count for the now combined document. In 4.1, some courts may have made an update to now include this additional combined current page number information when viewing a PDF Header.

5 4.2: CM/ECF Mobile Query for Public Users

CM/ECF mobile is an interface that allows query access to CM/ECF information from devices, which have a screen size of only a few inches, and are often limited in bandwidth (data transfer speed). Courts now have the option to provide a mobile query access link to the public.

Upon selection of the mobile login link for the designated circuit, the following screen displays:

The public user can enter his/her PACER login and password or an ECF login and password. Logging in to an ECF account will allow access to any sealed information the user is authorized to see. Upon selection of the Login button, the following screen displays:

The user can now enter either a case number or party/attorney name and click the Search button to view the results. **Tip**: It can be difficult to find the hyphen key on a mobile device, so a space can be used instead when searching for a case number, such as '11 1063'.

The user can perform a new search at anytime by entering a case number or party/attorney name and clicking the **New Search** button. **Tip**: You may be able to use the "return" key after typing in a field to initiate the search, depending on how your mobile device is configured.

The user can click the **Docket Search** button to access the public docket sheet and view all docket entries for the selected case or further limit the docket entry results by entering a text search value.

Tip: You can enter all or part of a date in the "Docket Search" field to find only entries with a matching date. Therefore, typing '6/06' will match entries made on June 06 (as well as any entries that have that date within the text). You can also use the standard browser search facilities (typically called 'find') to look for a particular place in a large display of docket text.

Tip: On a **Blackberry**, you can use the "b" key to move to the bottom of a big page of data, and "t" to move to the top. Other devices may have similar keyboard shortcuts.

The **Court Home** button will take you to the court's home page.

The **Logout** button will invalidate the session, so it can no longer be used.
